HOUSE STRENGTHENS OPEN PARLIAMENT INITIATIVE, PIONEERS LIVE STREAMING OF PUBLIC PETITIONS HEARING

he House of Representatives on Tuesday, took a significant step forward in its commitment to transparency and accountability, as it launched the live streaming of hearings by the House Committee on Public Petitions. This move is in line with the House's Legislative Agenda, particularly its focus on Open Parliament (Agenda 6).

Speaking to petitioners and respondents during the hearing, Chairman of the Committee, **Rep. Mike Etaba** (APC, Cross River), explained that the initiative was part of the House's efforts to demonstrate transparency in addressing issues that affect Nigerians, regardless of their circumstances.

Emphasising that the live streaming of hearings was a key part of the House's commitment to fostering openness. Rep. Etaba stated: "We want Nigerians to see for themselves that the House is transparent in its dealings with matters concerning the wellbeing of all Nigerians." "By the leave of the Speaker and my dear colleagues, we seek to bring succour to Nigerians by ensuring that they get unassailable justice in any case brought before us," he added.

Rep. Etaba also highlighted the Committee's active presence on Facebook, [Public **Petitions** Committee, 10th House of Representatives] encouraging the public to regularly visit the page for updates on hearings and activities. "We have a robust Facebook presence, which has been running for some time now, and I urge Nigerians to continue engaging with us through this platform," he added.

This development comes just weeks after the House formalised partnership with Human Rights Radio/TV (Brekete Family) for a weekly radio show, "Wetin Representatives Dey Do Sef?" This collaboration aligns with the House's goal of establishing partnerships with NGOs, think tanks, and civil society organisations that promote transparency, accountability, and public engagement.

Since its inauguration in June 2023, the 10th House of Representatives has prioritised numerous initiatives outlined Legislative Agenda on Strengthening Good Governance (Agenda 1) and Open **Parliament** (Agenda focused on 6) upholding

democratic principles such as accountability, public engagement, and trust-building.

The constitution of the House Special Committee on Media and Public Affairs, led by Rep. Akin Rotimi Jr. (APC, Ekiti) in July 2023, has further strengthened the House's efforts in communications. The Committee under his leadership, has thus spearheaded a transformative approach to managing communications for the Green Chamber, with an timely, factual, emphasis on and innovative storytelling.

As part of its commitment to good governance, the 10th House recognizes that improving service delivery within the legislature is crucial to enhancing the efficiency and effectiveness of the legislative process. This, in turn, can lead to better governance, increased public trust, and more meaningful representation.

The Rt. Hon. Abbas Tajudeen, PhD, GCON-led House has also embraced

e-parliament initiatives such as the Facebook Live Streaming for the Public Committee **Petitions** Hearings, recognising essential for them as modernising legislative processes and democratic participation. increasing Ultimately, these initiatives aim to improve the efficiency, transparency, functionality overall of parliamentary work.

Central to the House's Open Parliament Agenda is the recognition that promoting citizen engagement and ensuring transparency are vital to strengthening democratic institutions. "An open parliament fosters a two-way dialogue between elected representatives and the citizens they serve," the House stated in its agenda.

"The 10th House, dubbed the 'People's House,' will ensure that legislative processes are transparent and make our records, proceedings, and decisions accessible. When citizens can see how decisions are made, it enhances trust in the democratic process."

peaker of the House of Representatives, Rt. Hon. Abbas Tajudeen, PhD, GCON, on Friday joined President, Commander-in-Chief, Bola Ahmed Tinubu, GCFR, in bidding farewell to the late Chief of Army Staff, Lieutenant General Taoreed Lagbaja, at the National Military Cemetery in Abuja.

The late COAS, who passed away on Tuesday, November 5, at the age of 56, was interred with full military honours on Friday, November 15, 2024. Speaker Abbas described the late General as a patriotic Nigerian who served his fatherland with zeal, dedication, and sacrifice.

In his tribute, Speaker Abbas prayed for the repose of his soul and strength for the nation to bear the irreplaceable loss. He added that the late Lagbaja would be remembered for his doggedness and resilience.

The event brought together family, colleagues, and numerous top military

officers, as well as civilian dignitaries. In attendance were Vice President, Senator Kashim Shettima, GCON, President of the Senate, **Senator** Godswill Akpabio, GCON, members of the Federal Executive Council, and Service chiefs led by the Chief of Defence Staff, General Christopher Musa. The Inspector General of Police, Kayode Egbetokun, also participated, with each dignitary laying wreaths at the grave of the late Army Chief with heartfelt reverence.

On Wednesday, November 6, 2024, the House of Representatives had issued a statement mourning the loss of Lt. Gen. Lagbaja, extending heartfelt condolences to his family, the Defence Headquarters, the Nigerian Army, the people and government of Osun State, and all Nigerians during this painful period.

The statement reflected on his unwavering dedication and significant contributions to the service of the

nation. Notably, recalled his it participation in the inaugural edition of the House's Sectoral Debate on Security in November 2023, which highlighted his deep commitment to addressing the challenges facing the Army ensuring its successes under his leadership.

"Lt. Gen. Lagbaja's leadership was instrumental in the recent successes against banditry and terrorism in various regions of the country. His legacy,

particularly his modest but impactful achievements in a short period as Chief of Army Staff, will continue to resonate in the years to come," the statement read in part.

At the event, President Tinubu conferred a posthumous national honour, Commander of the Federal Republic (CFR), on Lagbaja, describing him as one of his best appointees, in recognition of his exceptional service to the nation.













HOUSE DELIVERS JUSTICE FOR HOST COMMUNITIES, ORDERS TOTAL ENERGIES TO ADDRESS NEGLECT

he House Committee on Public Petitions on Wednesday, directed Total Energies Nigeria Limited and the Nigerian Upstream Petroleum Regulatory Commission (NUPRC) to immediately establish a separate Host Community Development Trust (HCDT) for the Ikot Abasi, Ibeno, and Mbo communities in Akwa Ibom State.

This directive followed a petition calling on Total and NUPRC to honour a memorandum of understanding (MoU) Total Energies had signed with the local government councils in Akwa Ibom, which had designated a local government area as a host community. However, by August 2022, Total Energies excluded these communities from the HCDT and failed to reinstate them despite multiple appeals.

In his ruling, Committee Chairman, Rep. Mike Etaba (APC, Cross River) expressed strong dissatisfaction with the way Total Energies and NUPRC handled the issue, particularly considering the communities' efforts to resolve the

matter through proper channels.He reaffirmed that the 10th House of Representatives is the *People's House* and will not allow any Nigerian to suffer unjustly.

The Committee subsequently ordered Total Energies and NUPRC to take immediate action to rectify the situation and reinstate the affected communities into the Host Communities Development Trust.

Reacting to the ruling, **Eyoh Asuquo**, Counsel for the Communities, expressed his gratitude. "On behalf of the communities of Mbo, Ibeno, and Ikot Abasi, I extend our profound gratitude to the Speaker of the House of Representatives, Rt. Hon. Abbas Tajudeen, PhD, GCON, and Rt. Hon. Mike Etaba, Chairman of the House Committee on Public Petitions," Asuquo said.

He continued, "Your decision on our petition is a testament that you are indeed the Representatives of the people who would uphold and protect Nigerians against the oppressive and obnoxious decisions of oil companies and regulators especially Total Energies."

Asuquo noted that the ruling would be a landmark moment, recorded in history as evidence of the positive impact the House of Representatives can have on the lives of ordinary Nigerians.

- (f) Making recommendations on the desirability of the House sending Women Delegation to specific Inter Parliamentary Women events
- (g) Representing the National Assembly in International Parliamentary Associations or Groupings on women's matters generally

The decision for the oversight recess was communicated to Honourable Members by the Speaker, Rt. Hon. The Speaker urged lawmakers to make the most of this period to strengthen governance and fulfill their oversight responsibilities.

It also served as a critical step in evaluating the performance of MDAs ahead of the upcoming budgetary process.

REPS VISIT EFCC HEADQUARTERS, EXPRESS SATISFACTION WITH BUDGET IMPLEMENTATION AND OUTCOMES



he House Committee on Financial Crimes visited the Corporate Headquarters of the Economic and Financial Crimes Commission (EFCC) in Abuja on Tuesday for an oversight assignment, aimed at evaluating the Commission's ongoing efforts in combating corruption and financial crimes across the nation.

Chairman of the Committee, Rep. Ginger Obinna Onwusibe (LP, Abia), reaffirmed the Committee's unwavering support for the EFCC's autonomy and its effectiveness in tackling financial crimes that threaten national security and economic stability.

Rep. Onwusibe also expressed satisfaction with the Commission's budget implementation and outcomes, noting that the Committee, alongside the National Assembly, would continue to support the EFCC with increased funding in the 2025 budget to help the

Commission achieve even greater success in its mandate.

During the visit, the Executive Chairman of the EFCC, Mr. Ola Olukoyede, provided update on the an activities, Commission's highlighting significant achievements. Olukoyede reported that between October 18, 2023, and October 18, 2024, the Commission secured over 3,500 convictions. He emphasised that the EFCC had placed a strong focus on prevention in the past year, achieving more cost-efficient and impactful results. He also pointed out that no fight against corruption and financial crimes can succeed without strengthening the economy considered asset recovery a critical tool in both fighting financial crimes and deterring corruption.

Addressing the Commission's workload, Olukoyede revealed that in the past year alone, the EFCC had received over 17,000 petitions and was actively investigating more than 20,000 cases. He added that apart from the convictions, the Commission had several cases pending in court, and over 4,800 new case files had been opened between October 2023 and now.

The oversight visit also provided an opportunity for the Committee members with EFCC engage to leadership on operational challenges, successes, and strategic priorities for the coming months. Key discussions focused on the effective allocation of resources strengthening collaboration and between the EFCC and other relevant government agencies to bolster

Nigeria's national anti-corruption framework. The also Committee conducted progress reviews of key investigations ongoing and prosecutions, ensuring alignment with legislative mandates public and expectations.

This visit underscores the continued commitment of the 10th House of Representatives in alignment with its Legislative Agenda (2023 - 2027) to upholding transparency, accountability, and the rule of law in Nigeria's anti-corruption efforts, ensuring that the EFCC remains equipped to carry out its vital mandate effectively.

REPS TOUR KEY AUTO PLANTS IN LAGOS, PLEDGE SUPPORT FOR LOCAL MANUFACTURERS

REPS TOUR KEY AUTO PLANTS IN LAGOS, PLEDGE SUPPORT FOR LOCAL MANUFACTURERS

he House Committee on Industry this week visited key vehicle assembly plants in Lagos as part of an oversight mission, reaffirming its commitment to supporting local manufacturing and strengthening Nigeria's automotive sector.

Accompanied by senior management from the National Automotive Design and Development Council (NADDC), the delegation toured several prominent automotive plants, including Coscharis Motors, Mikano Motors Factory, Choice International Group (CIG Motors), and Dangote Sinotruk. The aim was to progress assess the of Nigeria's automotive industry, identify challenges, and pinpoint areas for improvement.

Speaking at Coscharis Motors on Thursday, Rep. Dolapo Badru, Chairman of the Committee, emphasised the House's commitment to fostering an environment conducive to business growth. He noted the potential of local assembly plants to reduce Nigeria's reliance on imported vehicles while stimulating economic growth.

"Our goal is to create a favourable business climate, enabling you to expand your operations and contribute to Nigeria's industrial growth," Rep. Badru stated.

During the visit, Coscharis Motors' Group Managing Director, Josiah Samuel, gave the delegation a tour of the facility, showcasing its advanced production capabilities. "This facility features a multi-model production line assembly plant. What we have here is Complete Knock-Down (CKD) assembly, utilising an automated Established in 2013 under Ford Motor Company's quidance, we manufacture the Ford Ranger SUV and other brands," Samuel explained.

He also highlighted the company's exceptional dismantling capabilities. "Our dismantling capabilities are unmatched, with only one other company rivalling our level. While some firms disassemble 20-50 components, our extent is unparalleled," he added.

Director of Research, Design, and Development at the NADDC, Engr. Dr. Fidelis Achiv, who represented the

NADDC Director-General, stressed the supporting local importance of manufacturers that produce high-quality components to meet international standards. He called for greater collaboration between Nigeria's assembly plants and local suppliers, rather than depending on international sources for parts.

"It is essential that Nigerian assembly plants patronise local manufacturers producing high-quality components that meet international standards. This will help boost local content and foster growth in the automotive sector," Achiv stated.

At other plants, the delegation explored strategies to enhance production capabilities and broaden customer bases beyond government contracts. Rep. Badru also highlighted some key gaps in Nigeria's automotive sector, including the need for more service centres and increased local

manufacturing of CKD vehicles. He noted that the absence of sufficient service centres across the country could hinder consumer confidence and impact vehicle sales, stressing the importance of developing nationwide infrastructure to address these gaps.

The visits provided Members of the House with firsthand insights into the challenges faced by local manufacturers and offered an opportunity to discuss strategies for enhancing their growth and competitiveness. "Together, we are committed to strengthening Nigeria's automotive sector for a sustainable future," the delegation concluded.

As outlined in its Legislative Agenda on Economic Growth and Development (Agenda 4), the 10th House of Representatives remains committed to creating an environment conducive to industrial growth and innovation, which is essential for Nigeria's broader economic development.

The House Committee on Federal Polytechnics and Higher Technical Education recently visited several federal polytechnics across the country, including the Federal Polytechnic Kaura-Namoda in Zamfara State, the Federal Polytechnic Bauchi in Bauchi State, the Federal Polytechnic Kaltungo in Gombe State, and the Federal Polytechnic Bali in Taraba State.



During the oversight visits, the Committee, led by Rep. Fuad Kayode Laguda (APC, Lagos), encouraged the Rectors and management teams of the institutions to adopt innovative approaches in their academic offerings. Rep. Laguda urged the polytechnics to introduce courses and programmes tailored to address local challenges and leverage the untapped potentials within their catchment areas.


